

## Supporting the Pennsylvania Bar Foundation

- **Life Fellow** - Each year, the Pennsylvania Bar Foundation Board of Directors **nominates** distinguished individuals who have demonstrated their commitment to the profession through their **Bar leadership** activities to become **Life Fellows**. Life Fellows **pledge \$1,000** to the Pennsylvania Bar Foundation. The pledge may **be paid in a lump sum or in four consecutive annual installments of \$250**. **Young Lawyer Life Fellows** pledge **\$500** to the organization. As with the senior membership, this amount may be paid in a lump sum or in four consecutive annual installments of \$125.
- **Commonwealth Club** - Commonwealth Club Fellows are dedicated to supporting youth justice educational efforts that teach Pennsylvania's youth about their legal rights and responsibilities and the privileges of democracy. **Commonwealth Club members pledge a minimum of \$5,000** to the Pennsylvania Bar Foundation. The contribution may **be paid in a lump sum or over no more than ten years in annual installments**.
- **Keystone Society** - Keystone Society Fellows are **pivotal contributors**, providing critical **support to the Foundation's Endowment Fund**. Keystone Society members **pledge a minimum of \$10,000** to the Pennsylvania Bar Foundation. The contribution may **be paid in a lump sum or over no more than ten years in annual installments**.

- **Bi-annual Recognition**

New members are annually inducted into the Foundation by a member of the Supreme Court. The ceremony is typically held during the Association's Annual Meeting.
